The audit was performed according to the Swiss Standards "ZertES SR 943.03 (January 2017), VZertES SR 943.032 (January 2017), TAV SR 943.032.1 (January 2017) as well as the European Standards "ETSI EN 319 411-1, V1.1.1 (2016-02)", "ETSI EN 319 411-2, V2.1.1 (2016-02)", "ETSI EN 319 401, V2.1.1 (2016-02)", "ETSI EN 319 421, V1.1.1 (2016-03), and "ETSI EN 319 422 V1.1.1 (2016-03)" considering the requirements of the "ETSI EN 319 403, V2.2.2 (2015-08)" for the Trust Service Provider Conformity Assessment.

The full annual audit was based on the following policy and practice statement documents of the TSP:

1. Swiss Government PKI – Root CA I: Certificate Policy and Certification Practice Statement of the Swiss Government Root CA I, version 2.1, as of 13th June 2013
