The certification for the control objectives and control framework was performed under the official accreditation against ISO/IEC 17021-1 and its PKI-framework based on the certification of the Swiss Trusted Service Provider (TSP), named Federal Office of Information Technology, Systems and Telecommunication (FOITT).

The audit was performed as full annual audit at the TSP's location in Berne. It took place from 7<sup>th</sup> June 2022 until 7<sup>th</sup> December 2022 and covered the period from 19<sup>th</sup> November 2021 until 31<sup>st</sup> October 2022.

The audit was performed according to the European Standards "ETSI EN 319 411-1, V1.2.2 (2018-04)" and "ETSI EN 319 401, V2.2.1 (2018-04)" considering the requirements of the "ETSI EN 319 403, V2.2.2 (2015-08)" for the Trust Service Provider Conformity Assessment.

The full annual audit was based on the following policy and practice statement documents of the TSP:

1. Swiss Government PKI – Root CA I: Certificate Policy and Certification Practice Statement of the Swiss Government Root CA I, version 3.0, as of 5<sup>th</sup> January 2021

The Sub-CAs that have been issued by the aforementioned Root-CA and that have been covered by this audit are listed in table 1 below. The TSP assured that all non-revoked Sub-CA's that are technically capable of issuing server or email certificates and that have been issued by this Root-CA are in the scope of regular audits.
