The audit was performed as full annual audit at the TSP's location in Berne. It took place from 5<sup>th</sup> September 2018 until 15<sup>th</sup> February 2019 and covered the period from 1<sup>st</sup> January 2018 until 31<sup>st</sup> December 2018.

The audit was performed according to the Swiss Standards "ZertES SR 943.03 (2016-3), VZertES SR 943.032 (2016-11), TAV SR 943.032.1 (2016-11) as well as the European Standards "ETSI EN 319 411-1, V1.2.2 (2018-4)", "ETSI EN 319 411-2, V2.2.1 (2018-4)", "ETSI EN 319 401, V2.2.1 (2018-4)", "ETSI EN 319 421, V1.1.1 (2016-03)", and "ETSI EN 319 422 V1.1.1 (2016-03)" considering the requirements of the "ETSI EN 319 403, V2.2.2 (2015-08)" for the Trust Service Provider Conformity Assessment.

The full annual audit was based on the following policy and practice statement documents of the TSP:

1. Swiss Government PKI – Root CA I: Certificate Policy and Certification Practice Statement of the Swiss Government Root CA I, version 2.1, as of 13<sup>th</sup> June 2013
